Dear Applicant,

Please find enclosed the Residency Application Form for the PAL Vancouver project at the corner of Georgia and Cardero Streets in Vancouver.

Please be sure to complete the Residency Application Form in full and attach all required documents or your application will be returned to you for completion which will delay the assessment of your application by the Resident Selection Committee. All questions asked are to assist the committee in making appropriate assessments.

Each member of a household should fill out their own application form unless one household member does not want to sign the lease. Household members who do not fill out their own application and sign the lease, may not be permitted to remain in the building if the approved member of the household were to move out or die. In the event both members of a household are applying, please include the name of the other person in your household in Section 2 of the Residency Application Form.

To substantiate your professional performing arts industry career, be sure to include a resume or work history and also list your affiliations with professional performing arts associations, organizations or unions.

The medical page must be signed by your doctor.

Personal references should not include family members.

Regarding your income. If you have the Tax Assessments for the past 3 years that is all that will be needed to substantiate your income. If you do not have these assessments copies of your income tax forms (without attachments) is required. If you have not filed your income tax then you will need to provide copies of all the relevant documentation that would be submitted with your income tax forms.

You may include a cover letter with your application if you feel there is additional information you would like the committee to know that would assist in assessing your application.

The assessment process at the moment will take up to 3 months. You will be notified whether you qualify or not. Once qualified, applicants will be placed on an Admissions Waiting List.

It is expected that in March 2006 the first residents will be moving in.
